The Judiciary Committee has jurisdiction over a wide range of legislative and oversight issues, including oversight of the U.S. Department of Justice, constitutional law, federal criminal law, voting rights, immigration and naturalization, intellectual property law, and antitrust law. Intern assignments will vary depending on the work of the Judiciary Committee each semester. Examples of potential responsibilities include: researching policy issues under the committee's jurisdiction, conducting legal research, attending briefings and hearings on the Hill, drafting memos, supporting committee counsels, supporting committee clerks and professional staff members, providing administrative support, including answering calls, delivering correspondence, and setting up the hearing room.
